- 2. We are accountable to the friends and supporters of Charlie 22 Outdoors.
- 3. We are to conduct ourselves as Godly men and women, treating everyone at every event with dignity and respect.
- 4. We are to protect and respect everyone. No flirting, foul language, inappropriate gestures or comments, will be tolerated.
- 5. We are protect all children who are at the events.
- 6. We are to be role models and Christian examples.
- 7. We are only use wholesome talk that uplifts and encourages. Do not use foul language, words or phrases that will be offensive to God or others who are surrounding you.
- 8. No alcohol or other mind-altering substances of any nature will be allowed at any of the events.
- 9. We are accountable to State of Missouri officials and are to uphold any and all laws of the region.



- 10. Safety is ALWAYS our first thought.
- 11. When working with a landowner, follow these guidelines:
 - a. Always identify the landowner and get permission to enter or hunt their land. Try to visit in person, be courteous, and ask about rules. Face-to-face contact is important for landowners to learn more about you. They can put a face and vehicle with the person that will be on their property.
 - b. Be friendly and allow enough time to chat. A conversation can help you learn a lot about the surrounding area, wildlife movements, and the quality/quantity of the wildlife.
 - c. Ask about any rules and the landowner's property goals. Try to help him or her meet those goals. If the landowner wants a lower deer population to reduce crop damage, be sure to harvest does. If the landowner wants bucks to reach an older age class, pass up younger bucks.
 - d. Always be safe. Look out for livestock or roads when firing.
 - e. Keep an open line of communication with our landowners. They don't like surprises. If you tell them that you'll have two hunters on a certain date, don't show up with five.
 - f. Be respectful of the property. Leave it in better shape than you found it.
 - g. Did we mention to BE SAFE!
 - h. Give back. Do something for the landowner. They have allowed us to hunt on their property. It is a good idea to offer something in return.
 - i. Never trespass. If you shoot an animal and it enters someone else's property, ask the owner for permission to search their property.
 - j. We must also ask for permission each year to ensure we are still allowed to hunt their property.
 - k. Did we mention to BE SAFE!

As a volunteer, we are representatives of Charlie 22 Outdoors, and there can be no exceptions or excuses for violating any laws or conducting ourselves in a manner that is not pleasing to God. Anyone who is found intentionally violating a law will be reported to the local authorities and may be asked to leave the event. Those conducting themselves in a manner not pleasing to God, may also be asked to leave and may be prevented from volunteering at future events.
